

## Claim for personal tax credits - Form



*In order to be able to claim your personal tax credits at the Maternity/Paternity Leave Fund, the below information must be provided at the latest on the 20th day of the particular month for which you wish to apply for childbirth leave.*

- It is important that the parent provides the most recent information regarding the status of his or her personal tax credits in order to prevent exceeding the limits of the claim for personal tax credits. Parents are therefore asked to send the filled-out form after the most recent employee payroll calculations have been made by the employer, prior to the childbirth leave, and after this information has been announced on the Directorate of Internal Revenue -RSK- service webpage: [www.skattur.is](http://www.skattur.is).

The Directorate of Internal Revenue may in such instances ask that the Directorate of Labour cease temporarily to claim personal tax credits.

NB - If there is a note attached to your personal tax credits claim statement, or to the claim of your spouse, it may be necessary for you to contact the Directorate of Internal Revenue to get further information on how to claim the personal tax credits.

\*By his or her signature, the claimant and the spouse (if applicable) affirms that the information provided here is consistent with information regarding the claim for personal tax credits as recorded by the Directorate of Internal Revenue.
